

OTHER FEES

- A \$5.00 late fee may be posted to all accounts that are not current as of the 10th of the month.
- A \$25.00 fee will be added for each NSF item returned.
- A \$1.00 fee may be charged each time you forget to sign-in/out or clock-in/out.
- A late pickup fee of \$1.00 per minute will be charged when children are picked up after 6:00 pm.
- Activity fees (field trips, etc.) will be posted the day of the activity.
- Interest at a rate of 1% per month may be applied to amounts more than 30 days past due.
- A fee for contract changes will be charged as follows: \$5.00 for change #1, \$10.00 for change #2, \$15.00 for change #3, and so on.

Annual & Semiannual Tuition Discounts

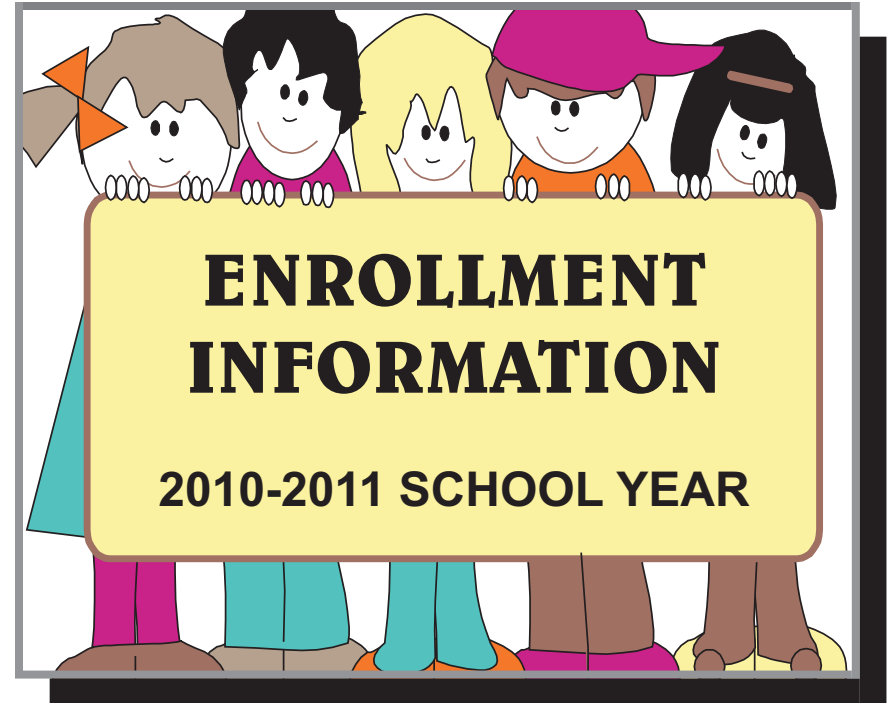

There are 180 days in the school year, and each of the 10 tuition installments covers 18 school days. Each of two summer sessions has 18 school days as well.

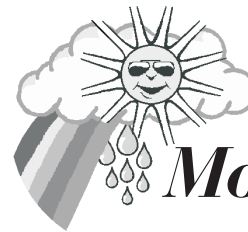

GENERAL INFORMATION FOR NEW ENROLLEES

Montessori in Motion offers classes for children age 2½ through 6th grade. If you wish to enroll a child, applications will be accepted upon completion of the following:

- An interview with the parent(s) and child. This interview is required for all **new** enrollees. Please telephone for an appointment at 253-565-3080. Office hours are 8:30 am to 4:30 pm.
- Completion of the enclosed “2010-2011 Application for Enrollment.”
- Completion of the enclosed “EZ-EFT™ Authorization Form.” (See enclosed brochure for more information about EZ-EFT™ and how it works.)
- Payment of the appropriate fees according to the timetable below. **NOTE:** At time of enrollment, fees for new enrollees must be paid by check, cash, or money order. Once enrolled, all payments will be processed automatically through the EZ-EFT™ system.
 - Application fee. \$75.00 **(NONREFUNDABLE)**
Always due with application. (Fee for each additional sibling is \$50.00.)
 - Work bond fee \$200.00 **(NONREFUNDABLE)**
Paid with EZ-EFT™ draft July 1, 2010. (Due with application if you enroll after June 18, 2010.)
 - First tuition installment Various (based on child's schedule)
Due with application if you enroll after July 20, 2010.
 - Second tuition installment Various (based on child's schedule)
Due with application if you enroll after August 13, 2010.
 - First contracted care installment . . . Various (based on child's schedule)
Due with application if you enroll after August 13, 2010.

DUE DATES FOR FEES FOR A CHILD RE-ENROLLING

Fees due will be paid automatically through the EZ-EFT™ system unless you re-enroll after the dates as listed below; then, you must pay the fees due at that time by check, cash, or money order.

- Application fee. \$75.00 **(NONREFUNDABLE)**
Due with application. Processed through EZ-EFT™ unless you re-enroll after June 18, 2010. (Fee for each additional sibling is \$50.00.)
- Work bond fee \$200.00 **(NONREFUNDABLE)**
Due July 1, 2010. Processed through EZ-EFT™ unless you re-enroll after June 18, 2010.
- First tuition installment Various (based on child's schedule)
Due with application if you re-enroll after July 20, 2010.
- Second tuition installment Various (based on child's schedule)
Due with application if you re-enroll after August 13, 2010.
- First contracted care installment . . . Various (based on child's schedule)
Due with application if you re-enroll after August 13, 2010.

TUITION

- Tuition payments will be posted to your child's account the first of each month, August 1, 2010 through May 1, 2011, and processed on or after the fifth of each month, August 5, 2010 through May 5, 2011.
- Tuition is an annual charge which you are required to pay regardless of absence due to illness or vacations. If a child is withdrawn before the end of the school year, 30 days' written notice is required. One month's tuition installment will be forfeited for notice of less than 30 days. **NOTE: There will be no discount on tuition or contracted care for children withdrawn after March 31, 2011.**
- Discounted rates are available for those choosing the annual or semi-annual payment option.
- A 10% sibling discount will be applied to the child with the smallest annual tuition amount.

CHILD CARE FEES

- Child care is available at a contracted monthly fee (see schedule for rates). (For example, 2 hours/day = \$50.00 x 2 = \$100.00/month)
- Any child care time incurred beyond the contracted time will be computed at the part-time rate. Part-time child care fees will be posted about the 15th of the month for the previous month's charges.

APPLICATION FEE – Due with application \$75.00/student*

- Due for **all** students
- Nonrefundable

Applications for new students will be accepted only after an interview with the parent(s) and child. If a child withdraws and then re-enrolls during the school year, an application fee will again be due. (*Fee for each additional sibling is \$50.00.)

WORK BOND FEE – Due July 1, 2010 \$200.00/student

- Due for **all** students
- Nonrefundable

This fee may be “worked off” during the school year by donations of time and/or materials to the school. You will be given a credit against the work bond fee of \$10.00 for each hour donated or a dollar for dollar value for materials or money donated up through May 31, 2011. That part of the Work Bond Fee that is “worked off” will be credited to your child's account during June. If your child does not re-enroll, any credit balances will be refunded at the end of June.

PLEDGE AMOUNTS:

Pledge amounts will process automatically each month along with any other fees due. Just fill out the form and turn it in with your application.
